This is for the information of the candidates seeking admission under Master's programme that the second round of counselling for Master's Programme scheduled to be held on 25.07.2024 for the Academic Session 2024-25 has **been postponed** due to some administrative reasons.

**Now, the University will conduct the 2<sup>nd</sup> round of counselling on 03.08.2024 (Saturday)**, the reporting time for the counselling sessions will be from 10:00 AM to 11:30 AM for marking attendance in the Dr L S Negi Auditorium located in the main campus at Nauni. The detailed category and college wise vacancy position will be uploaded on the University website later on.

However, the reporting time for candidates seeking admission under sports and co-curricular seats and who have secured 45 and above marks in the entrance examination before the counselling committee is 10:30 AM. The allotment of seats for the sports & Co-curricular will start at 10:30 AM sharp and marking of attendance before that is mandatory. The candidates seeking admission under the sports and co-curricular seats must present themselves before the Chairman of the counselling committee. Failure to do so will result in the seat being allotted to the next physically present eligible candidate on the merit list for sports and co-curricular activities.
