This is for the information of all candidates seeking admission to the **Undergraduate Programme** under **Normal and Self-Financing Seats** that the **Second round of counselling** for the **Academic Session 2026-27** is scheduled to be held as per the details below:

- **Counselling for Normal Seats:** 17.08.2026
- **Counselling for Self-Financing Seats:** 18.08.2026
- **Reporting time:** 10:00 AM to 11:00 AM (For marking attendance)

Counselling Fee:

All eligible candidates appearing for the first time in the counselling for Normal and Self-Financing Seats are required to pay a **non-refundable counselling fee of ₹1,000/-**. The payment shall be made through the QR Code/Link provided in **Annexure-I**. Candidates appearing for the first time in the counselling, including those who have already paid the requisite counselling fee during a previous round of counselling, are required to bring a hard copy of the payment receipt generated through the e-Shiksha Portal to the counselling venue. No other proof of payment, including screenshots or transaction details from UPI applications such as Google Pay or PhonePe or bank SMS/transaction messages etc shall be accepted.

It is further clarified that mere payment of the counselling fee does not guarantee seat allotment. The allotment of seats will be carried out strictly as per the provisions, available vacancies and eligibility criteria detailed in the *Prospectus for Undergraduate Degree Programmes* for the Academic Session 2026-27.

Important Instructions

- i. It is mandatory for all candidates to mark their attendance and appear before the Chairman of the Counselling Committee.
- ii. Candidates who fail to appear before the Chairman after marking attendance will not be considered for admission.
- iii. **Candidates seeking admission under the Sports and Co-Curricular Activities quota must submit their Sports and Co-Curricular Activities Certificates for consideration during this (2nd Round) of counselling only. Allotment of seats under this category will be done during the Next (3rd Round) round of counselling and shall be made strictly on the basis of merit in Sports and Co-Curricular Activities and in accordance with the provisions of the Prospectus. Candidates who do not submit their Sports and Co-Curricular Activities Certificates during this (2nd Round) round shall not be considered for allotment of seats under this category.**
- iv. Candidates who arrive after the reporting time will only be considered for seat allotment against any available vacancies at that time.
- v. Candidates seeking admission under the Rural Category must submit the original Rural Area Certificate at the time of counselling. The prescribed format for the certificate is attached as **Annexure-III**.
- vi. Candidates are advised to regularly visit the University website for updates and further information.

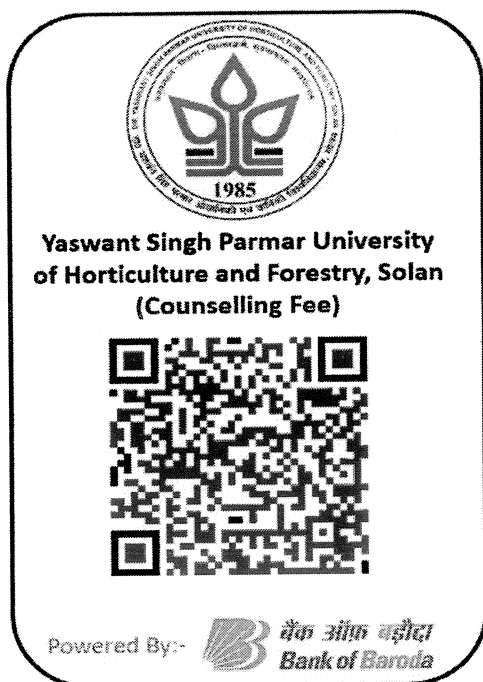
