### 2. Eligibility

Candidates must hold a Bachelor's degree in any discipline from a University/Institution recognized by the Government or a competent statutory authority.

**General category:** minimum 50% marks (or equivalent CGPA) in graduation.

**SC/ST/PwD category:** minimum 45% marks (or equivalent CGPA) in graduation a relaxation of 5%

### 3. Seats and Fee

**Seats:** 100 (Self-Finance) open for all.

#### **4. How to Apply**

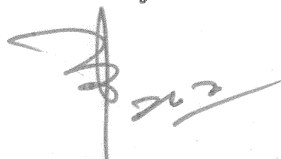
Candidates are advised to correctly fill the attached **Annexure-I** at the time of counselling, as it will be used to compute the composite score.

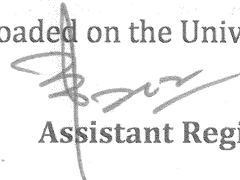
