- iii) Other terms and conditions of appointment shall be governed as per the Academic Regulations of the University.

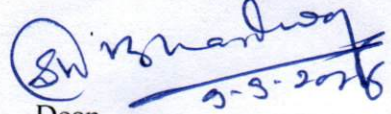
